

About Keynote Speakers

Professor Justin Yifu Lin is Dean of Institute of New Structural Economics, Dean of Institute of South-South Cooperation and Development and Professor and Honorary Dean of National School of Development at Peking University. He was the Senior Vice President and Chief Economist of the World Bank, 2008-2012. Prior to this, Professor Lin served for 15 years as Founding Director and Professor of the China Centre for Economic Research at Peking University. He is the author of more than 20 books including Going Beyond Aid: Development Cooperation for Structural Transformation, the Quest for Prosperity: How Developing Economies Can Take Off, and New Structural Economics: A Framework for Rethinking Development and Policy. He is a Corresponding Fellow of the British Academy and a Fellow of the Academy of Sciences for Developing World.





Professor Vincenzo Quadrini is James McN. Stancill Chair in Business Administration, and Professor of Finance and Business Economics in Marshall School of Business at University of Southern California. His research focuses on banking, entrepreneurship, financial contracts, and international economics. He has published articles in the American Economic Review, Journal of Political Economy, Review of Economic Studies, Journal of Financial Economics, and other leading economics and finance Journals. He is a research fellow at the Centre for Economic Policy Research, and was on the editor board of Review of Economic Dynamics, Quantitative Economics, and Journal of Financial Intermediation. Before joining USC, he was on the faculty at New York University, Duke University, and Pompeu Fabra University.

林毅夫教授是北京大学新结构经济学研究 院院长、北京大学南南合作与发展学院院 长、北京大学国家发展研究院名誉院长。 2008-2012 年, 担任世界银行首席经济学家 兼负责发展经济学的高级副行长。此前, 林毅夫教授担任北京大学中国经济研究中 心主任职务长达 15 年。 膺选为发展中国家 科学院(原第三世界科学院)院士及英国 科学院外籍院士。主要著作:《超越发展 援助: 在一个多极世界中重构发展合作新 理念》、《繁荣的求索》、《新结构经济 学:反思经济发展与政策的理论框架》等二 十余册。





Vincenzo Quadrini 教授是南加州大学马歇尔 商学院工商管理系 James McN. Stancill 主席和 金融与商业经济学教授。他的研究兴趣包括 银行学、创业学、金融契约和国际经济,他 的研究成果发表在《美国经济评论》、《政 治经济学杂志》、《经济研究评论》和《金 融经济学杂志》等顶级经济和金融期刊。 他 是经济政策研究中心研究员, 曾任《经济动 态评论》、《数量经济学》和《金融中介杂 志》主编。 在加入南加州大学之前,他曾在 纽约大学、杜克大学和庞培法布拉大学任 教。


About Conference Co-Chairs



Xiuping Hua is currently a Professor of Finance at Nottingham University Business School China, Director of UNNC-NFTZ Blockchain Laboratory, and Executive Deputy Director of Centre for New Structural Economics. Her research interests focus on financial technology and innovation finance. She has published articles in both academic journals and practitioners, such as the Journal of International Money and Finance, the European Journal of Finance, Review of Quantitative Finance and Accounting, Journal of Association for Information Systems, and so on. She has also worked as Principal Investigators for many research grants or consultancy programs of domestic and international governments and financial organizations.

Wei Huang is an associate professor in finance and accounting and Head of Department of Finance, Accounting and Economics at Nottingham University Business School China (Faculty of Business). Wei completed his PhD in finance in the University of Bristol, UK. He is also a holder of the Financial Risk Manager (FRM) and CPA (Australia) designations. Wei is currently an associate editor of *International Review of Financial Analysis*, *International Review of Economics and Finance*, *Finance Research Letters* and the China area editor of *Research in International Business and Finance*. His research lies in the areas of corporate finance, financial accounting, and corporate innovation. Wei has published more than 20 papers, including several single-authored ones, in leading international journals.





Yong Wang is Academic Deputy Dean of the Institute of New Structural Economics at Peking University. His research fields are economic growth, macroeconomics, political economy, China and India economies. He publishes academic papers on *Journal of Development Economics, Journal of Monetary Economics*, etc. and serves as a co-editor for *China and the World Economy* (SSCI). He is the author of several books including *Thinking and Debates on New Structural Economics* and *Industrial Policies: Summary, Reflection*. He won the First prize of the 8th university scientific research outstanding achievements of the Ministry of Education in 2020, won the Inaugural Zhang Peigang Young Economist Award in Development Economics in 2018. Yong obtained PhD in Economics from University of Chicago.








会议联合主席介绍

黄蔚是英国布里斯托大学金融学博士,现任诺丁汉大学商学院(中国)金融与会计学副教授,金融,会计与经济系主任。他也是金融风险经理人(FRM)和澳大利亚注册会计师(CPA)的持证人。黄蔚的研究主要在公司财务,财务会计,研发与创新领域。他目前担任两本 Journal Citation Reports 收录(SSCI)金融学一区期刊 International Review of Financial Analysis 和 Finance Research Letters 的副主编,二区期刊 Research in International Business and Finance 的中国区域主编,二区期刊 International Review of Economics and Finance 的副主编。迄今,他在国际主流金融,会计与经济学期刊上已发表论文 20 多篇,包括多篇独作。





王勇为北京大学新结构经济学研究院学术副院长、博士生导师。主要研究领域为经济增长、宏观发展、中国与印度经济、政治经济学。论文发表于 Journal of Development Economics、Journal of Monetary Economics 等国际学术期刊。担任 China and the World Economy (SSCI), Economic Modelling (SSCI) 副主编,以及 China Economic Review、《经济学(季刊)》等期刊特邀编辑。著有《新结构经济学思与辩》、《新结构经济学新在何处》、《产业政策:总结、反思与展望》。荣获 2020 年教育部第八届高校科学研究优秀成果一等奖,2018年首届张培刚发展经济学青年学者奖,香港科技大学商学院 Franklin 最佳教学奖。曾主持承担国家社科重点项目、中财办、国家发改委、商务部等多部政策课题。










Map of Downtown Ningbo 宁波地图
